#### WHO WE ARE

We are a platform specializing in INNOVATION AND TECHNOLOGY entirely focused on the MEDICAL CANNABIS sector.

#### WHAT WE DO

We have 3 business models: Venture Builder, Startup Acceleration and Corporate Consulting.

We introduced ourselves to the market in 2017 through a partnership with the US market data company of global cannabis to New Frontier Data and we launched the Medicinal Cannabis Report in Brazil - Overview 2018, this has given us a lot of visibility and our report projections for the Brazilian market remain the main reference in the country.

In 2018 we started our first acceleration cycle with two own startups, validating the acceleration program we developed. This work led to the raising of investment for The Green Hub and the two accelerated startups.

In 2019 we consolidated a joint venture with 4H Tecnologia em Saúde, a company that specializes in innovation and software development for the health sector. Our goal is to be inserted and explore the innovation ecosystem in the health area, bringing the medicinal cannabis theme to the center of the debates.

For 2020 we will have our first call of startups, we seek startups with differentiated solutions and teams having as points of interest Biotech, Agro-tech, and Digital. We will also hold a design thinking event focused on the medical cannabis market to foster and develop market solutions.

# Opportunity

Despite the MEDICAL CANNABIS industry regulatory advances throughout Latin America, licensing requirements vary from country to country, making investments and building a "scaling machine" for companies more challenging.

In Brazil, the region's largest potential market, the only access to MEDICAL CANNABIS also occurs through an import authorization individualized by ANVISA.

Latin America is a strategic center for the medical cannabis trade, and Brazil has the largest concentration of potential consumers in the region.

There is a lot of space to be explored in the domestic market, thus creating the possibility to strategically position pioneering projects (First Mover) throughout the chain, from solutions that are already legally exploitable to the pursuit of new technologies in various segments such as agrotech, health tech, edutech, data, and biotech.

# Main Focus

Educate and Inform future market leaders interested in the Medical Cannabis industry by promoting responsible, transparent and effective market practices learned from Cannabis Global's mature sectors.



#### WHO WE ARE

We are a medical platform and we take care of the entire journey of patients on medical cannabis treatment, we follow the patient experience giving all the necessary support.

We seek to be the main reference and multiplier for access to cannabinoid medicine, promoting quality of life and longevity for patients through good practices and knowledge generation.

#### WHAT WE DO


We empower the medical market through an educational platform, consolidate access with appointments and prescriptions at our clinics, and support patients through a support program that ranges from access to medication to adherence to treatment as prescribed by the physician.

#### **HISTORY**

In 2018 we went through The Green Hub's acceleration program, where we developed face-to-face courses for physicians with topics such as History of Medicinal Cannabis, Endocannabinoid System and Clinical Applications in different types of diseases. Through a partnership with the American company MM411, we launched two courses online MedPro with 12 modules for doctors and Medicinal Cannabis 101 for patients. We have so far had over 300 enrollments in our courses both offline and online. Our clinical model was validated in our offices in the cities of Santo André and São Paulo, centralizing the services in our medical director, we had more than 400 services between 2018 and 2019

By 2020 we will launch the CEC SYSTEM that is under development to automate the entire patient journey, and with this, we will begin the expansion plan for different cities throughout Brazil.







#### WHO WE ARE

With the approach of regulating the cultivation of cannabis in Brazil for medicinal purposes, we have built a platform that will be a reference in the production, manufacture and distribution of medicinal cannabis. We have developed a drug registration process with ANVISA for commercialization in the national territory.

#### WHAT WE DO

Mapping and acquisition of sheds or farms for cultivation, application of licenses for production and distribution of medicinal cannabis in Brazil and registration of medicines.

#### **HISTORY**

Anvisa is in the process of improving regulation with Public Consultations 654/2019 and 655/2019, which technical and administrative requirements for the registration of cannabis-based medicines and the cultivation of cannabis by pharmaceutical companies solely for medicinal purposes.

We understand this is the right time to position and invest, because when released, we may submit license requests for the activities in question.

Without ANVISA's disclosure, we are confident that the special committees in progress in the House of Representatives and the Federal Senate will succeed in 2020 with legislation favorable to the cultivation and registration of medicines in Brazil.

We are selecting international companies that can technically aggregate in the areas of cultivation and production of cannabis medicines, the goal is to explore the Brazilian market in a possible partnership.





# Startups

Connect health startups with the medical cannabis industry to adapt their solutions to this new market.

Work closely with startups to help improve their solutions and prepare them to enter the market.

Offer collaborative spaces in Rio de Janeiro and Sao Paulo and an acceleration program, featuring specialized multidisciplinary mentoring and financial investments by Startup in cycles per specified period.



Justice allows the family of Brazilian Anny Fischer, who suffers from rare syndrome, to import medical marijuana oil from the United States, and Anvisa now receives similar requests.

Federal Medical Council authorizes doctors to prescribe cannabidiol for children with epilepsy who have not been successful in other treatments

After court decision, Anvisa authorizes prescription and importation of drugs with THC Families get habeas corpus to grow and extract marijuana oil for their own medical use

Anvisa puts in public consultation proposal for Cannabis cultivation for research and production of medicines and another with rules for registration and post-registration of these products.

From 2015 to 2018 there was a 300% growth in the number of prescriptions, even with the market having many restrictions.



According to data provided by the Ministry of Agriculture, Livestock and Supply (MAPA), Brazilian agribusiness is responsible for generating about 23% of national GDP.

According to MAPA's Agribusiness Projections report, grain production in Brazil is expected to increase by up to 24% by 2027.

The Brazilian Tree Industry reported 14% and 2.2% growth in pulp and paper exports.

Brazilian agribusiness exports accounted for approximately 46% of Brazil's total


exports between 2015 and 2016.

Due to its high productivity, which can reach 12 tons of pulp per hectare, as well as its rusticity, which reduces the final cost of the product, Cannabis is becoming an option for the pulp and paper industry worldwide.

According to the Ministry of Agriculture, Livestock and Supply (MAPA), Brazilian consumption of cotton, the main raw material for the textile industry, should reach 2 million tons by 2022, requiring a planted area of 967 thousand hectares to supply this demand. added to exports.

In addition to an alternative for pulp and paper production, Cannabis is a great choice as a source of raw material for the textile industry, especially for the quality and high productivity of its fibers, which can be up to 3 times higher than cotton.
